LOCAL RULES

1. OUT OF BOUNDS — (RULE 27-1)

Beyond any fence, boundary walls or white stakes marking the boundaries to the golf course and real estate;

Including - practice facility, clubhouse and its surrounding areas and all internal roads running throughout the estate.

2. IMMOVABLE OBSTRUCTIONS — (RULE 24-2)

The following are to be deemed immovable obstructions and relief may be taken under Rule 24-2.

- All cart paths
- All fixed sprinkler heads
- All drainage catch basin covers
- All irrigation valve covers

3. PROTECTION OF NEWLY PLANTED AND STAKED TREES (RULE 24-2b)

If such a tree interferes with a player's stance or the area of his intended swing, the ball must be lifted, without penalty, and dropped in accordance with the procedure prescribed in Rule 24-2b (Immovable Obstruction).

4. MONTE REI NATIVE AREAS (RULE-26)

In the formative years of establishing and maintaining native areas at Monte Rei, all native areas bordering normal playing surfaces will be deemed as a lateral hazard and relief may be taken under Rule-26.

5. WATER HAZARDS (RULE 26)

- Water hazards are defined by yellow stakes.
- Lateral water hazards are defined by red stakes.

6. GROUND UNDER REPAIR (25-1)

All areas indicated by GUR and/or bounded by blue lines are ground under repair from which play is prohibited. If a player's ball lies in the area, or if it interferes with the player's stance or area of his/her intended swing, the player may obtain relief under Rule 25-1.

7. ADDITIONAL INFORMATION

All measurements from sprinkler heads and distance markers (located in centre of the fairways) are in meters to the front edge of the green.

Please repair all pitch marks and fill divots with sand provided.

Please rake bunkers after your shot has been played.

SPEED OF PLAY

Please uphold the club's speed of play policy and cooperate with the player assistants at all times.

Pin location sheets are provided in golf carts.
